**NOTICE OF INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION**

A draft Mitigated Negative Declaration has been prepared by the San Dieguito River Park Joint Powers Authority (JPA) for the project listed below:

**SUBJECT:** PAMO VALLEY SEGMENT OF THE COAST TO CREST TRAIL, to construct a 3-mile-long segment of the San Dieguito River Park Coast to Crest Trail in Pamo Valley near Ramona, California.

The JPA has conducted an environmental assessment of the subject project pursuant to the California Environmental Quality Act (CEQA) and prepared an Initial Study. The recommended finding is that the project will not have a significant effect on the environment because mitigation measures have been incorporated into the project to avoid any significant environmental effects. Therefore a Mitigated Negative Declaration will be recommended for adoption by the San Dieguito River Park JPA.
